Purpose

The purpose of this privacy policy (this "Privacy Policy") is to inform users of our Site of the following:

Who We Share Personal Data With

Collaborators

We may disclose user data to any member of our organization who reasonably needs access to user data to achieve the purposes set out in this Privacy Policy.

Other Disclosures

We will not sell or share your data with other third parties, except in the following cases:

- 1. If the law requires it;
- 2. If it is required for any legal proceeding;
- 3. To prove or protect our legal rights;
- 4. To buyers or potential buyers of this company in the event that we seek to sell the company. If you follow hyperlinks from our Site to another Site, please note that we are not responsible for and have no control over their privacy policies and practices.

How Long We Store Personal Data

User data will be stored until the purpose the data was collected for has been achieved.

You will be notified if your data is kept for longer than this period.

How We Protect Your Personal Data

We rely on our web service providers' browser encryption and data storage mechanisms to protect your security. No data is automatically or manually collected beyond the information you specifically provide in the contact form. All data provided is only accessible to our collaborators.
